The NTS is applicable to all suppliers within the Rolls-Royce Civil Aerospace Supply Chain.

Introduction:

You will be aware of the changes taking place in Rolls-Royce under the overall leadership of Warren East, Chief Executive Officer, which aims to further strengthen and improve our business, ensuring we continue to deliver excellence and value to our customers. Simon Burr – Director Engineering & Technology: Simon will be responsible for the Engineering function.
