Scope / Applicability:

The following routing instructions apply to shipments that are shipped for Rolls-Royce Corporation (Indianapolis) or for third party shipments when authorized by Rolls-Royce Purchasing for items related to manufacturing.

It is mandatory that the Roll-Royce purchase order number or project number be recorded in the shippers reference section of the FEDEX, carrier freight bill or air way bill.

Introduction:

These instructions apply only when Rolls-Royce Corp. is responsible for the transportation charges.

- Shipments must be shipped on a freight "Collect" basis. "Prepaid & Add" shipment terms are not authorized.
- Third Party billing to Rolls-Royce Corp. must be authorized by the MRPC/buyer, with a completed form on file with RRC transportation services.
- Do not request insurance on any shipment unless authorized by RR Transportation.
- Authorization for air freight, heavy air express (>150#), expedited or other premium shipments must be provided by RRC traffic/CEVA Logistics.
- Multiple packages that are shipped on the same day must be consolidated. If the items cannot be
 packaged in the same box, then multiple cartons should be processed as ONE shipment. If the
 consolidation results in shipment > 150#, contact CEVA Logistics.
- These routing instructions are subject to individual customization as needed.
